Color choice of white, black, or gold will be made once building colors are chosen. Not sure about illumination yet. Will have to see how things look but if lights are needed, they would be external illumination and in keeping with the time period of the Village downtown historic area.

It was noted that they had changed the burgundy accent color to gold so the Board felt adding that to their list of possible sign colors was appropriate.
